Spend six days in the Hudson River Valley at a glorious time of the year, when the autumn foliage will provide a spectacular backdrop to grand estates and historic homes. Private tours and special receptions distinguish this program, which will be accompanied by Morrison H. Heckscher, Curator Emeritus of the American Wing at The Metropolitan Museum of Art.

Begin at The Met with an exclusive curator-led tour of the American Paintings and Sculpture galleries before driving to New York's Westchester County. Special visits await at the Armour-Stiner Octagon House, a domed villa in Irvington; Boscobel, a fine example of Federal architecture; and Edgewater, Richard Jenrette's beautifully restored residence on the Hudson. Tour Olana, the Moorish-style castle of Frederic E. Church, and dine with the owner at Midwood, a late 19th-century home with dramatic river and mountain views.

Other extraordinary houses on our itinerary include Lyndhurst, America's premier Gothic Revival mansion, and Rokeby estate, the grand mid-century Astor residence. See the outdoor sculptures on a guided visit of Storm King Art Center; take High Tea during a chartered cruise on the Hudson River; and enjoy lunches at the Culinary Institute of America and Blue Hill at Stone Barns, renowned for its farm-to-table cuisine.

TRAVELING WITH YOU



Morrison H. Heckscher joined the staff of the American Wing of The Metropolitan Museum of Art in 1969 and was made the Anthony W. and Lulu C. Wang Curator, Department of American Decorative Arts in 1998, and Lawrence A.

Fleischman Chairman of the American Wing in 2001. He received his BA from Wesleyan University, his MA from the Winterthur Program in Early American Culture at the University of Delaware, and his PhD from Columbia University. During his career, Mr. Heckscher focused his research, publications, and exhibitions on 18th-century American furniture and 19th- and 20th-century American architecture. He is widely acclaimed for his transformation of the American Wing as he oversaw its decade-long renovation and re-installation. He was named Curator Emeritus of the American Wing upon his retirement in 2014. Mr. Heckscher has served on the boards of the Society of Architectural Historians, the American Friends of the Attingham Summer School, and Scenic Hudson. Currently he is a trustee of the Henry Francis du Pont Winterthur Museum. •

NEW YORK CITY

Saturday, October 15

Arrive independently in New York and gather in the early evening at The Metropolitan Museum of Art for a curatorled tour of the American Wing's rich holdings of art and architecture of the Hudson Valley. Particular attention will be paid to mid-19th-century landscapes by Thomas Cole and Frederic E. Church. Enjoy a welcome dinner in the Museum's Terrace Room. For those who wish, overnight accommodations can be arranged nearby, at The Surrey.

NEW YORK CITY • RHINEBECK

Sunday, October 16

Gather for breakfast at Café Boulud at The Surrey before driving to Westchester County for a visit at the Armour-Stiner Octagon House in Irvington. This exotic, domed villa is now the residence of preservation architect Joseph Pell Lombardi. At Boscobel, States Dyckman's elegant 1808 Federal mansion, a private lunch is followed by a tour of the important collection of Federal period furniture and decorative arts. Continue next door to landscape painter Thomas Prichard Rossiter's Fair Lawn, an 1860s Italianate villa with spectacular river views. Drive to Rhinebeck and check in for three nights at the Beekman Arms and Delamater Inn.

RHINEBECK

Monday, October 17

Following a morning lecture, drive to Barrytown for a private visit at Edgewater, home of financier and preservationist Richard Hampton Jenrette. This classical mansion, with its grand temple portico, is furnished appropriately with pieces by master craftsman Duncan Phyfe. Enjoy a guided tour and lunch at Wilderstein Mansion, a charming Queen Anne-style relic of the 1880s with interiors by Joseph Burr Tiffany (Louis Comfort Tiffany's cousin) and landscaping by Calvert Vaux. A visit is arranged with members of the Astor/Aldrich family at Rokeby estate, a palimpsest of 200 years of Hudson River history and taste. Return to the hotel for dinner.

UPPER HUDSON VALLEY

Tuesday, October 18

Today we focus on the historic upper Hudson River Valley. Begin with a tour of Olana, the hilltop Moorish fantasy created in the 1870s by Calvert Vaux for Hudson River School artist Frederic Edwin Church. There will be free time to explore downtown Hudson, the country's first chartered city. See artist Thomas Cole's former residence, Cedar Grove, and then enjoy High Tea on an afternoon cruise along the Hudson River. A special evening visit is arranged at Midwood, the late 19th-century Livingston family home with dramatic river and mountain views, where we will dine with owner Joan K. Davidson.





HUDSON RIVER VALLEY Wednesday, October 19

Following a morning lecture, stroll amidst the splendor of the Gilded Age at the Vanderbilt Mansion at Hyde Park. Lunch is at the Culinary Institute of America, which has set the standard for excellence in professional culinary education for over six decades. Cross the Hudson River to Ulster county for private visits at historic residences, including the Cornelius Wynkoop Stone House, the grandest pre-Revolutionary Dutch stone house in Ulster county and now owned by former Met curator Gary Tinterow. Check in at Mohonk Mountain House, the last of the Victorian hotels that once graced the Catskills and a National Historic Landmark, for a two-night stay.

HUDSON RIVER VALLEY

Thursday, October 20

Attend a morning lecture before exploring the Dutch-style stone architecture along historic Huguenot Street in New Paltz. Then depart for Storm King Art Center. On a guided tour see the outdoor sculptures and site-specific commissions by artists including Alexander Calder and Richard Serra. We are invited for lunch and a private visit at Stonihurst and Ananouri, adjacent riverfront family estates at Highland Falls, where we will be guests of Anne Sidamon-Eristoff and Mrs. Constantine Sidamon-Eristoff. Return to the hotel for dinner.

HUDSON RIVER VALLEY • NEW YORK CITY Friday, October 21

Drive through the scenic Hudson River Valley to Lyndhurst, the quintessential American Gothic Revival villa. The Duchess de Talleyrand-Perigord, daughter of robber baron Jay Gould, preserved the property until it was acquired by the National Trust. Celebrate our trip with a cocktail reception and lunch at Blue Hill at Stone Barns, renowned for its farm-to-table cuisine. Return to New York by late afternoon. •


